

Wesley Township Board Minutes May 8, 2012– 7:00 p.m.

Supervisor Jay called the meeting to order at 7:40 p.m. Supervisor Jay led the pledge of allegiance. Present were Supervisor Jay, Road Commissioner Rodawold, Clerk Vasko, Trustees Donohue, Gabriel, and Tennant. Absent were Assessor Rodawold and Trustee Stetzo.

There were no public comments.

Trustee Gabriel made a motion to approve the minutes of the April 12, 2012 meeting. Motioned seconded by Trustee Tennant. Motion passed unanimously by voice vote.

Clerk Vasko presented the Township bills totaling \$8,206.93. Motion made by Trustee Gabriel to approve the bills, motion seconded by Trustee Tennant. Roll call vote was taken, Donohue – yes; Gabriel – yes; Tennant; Motion passed.

Clerk Vasko presented the Assessor's bills totaling \$726.85. Trustee Donohue made a motion to approve the Assessor's bills, Trustee Gabriel seconded it. Roll call vote was taken, Donohue – yes; Gabriel – yes; Tennant - yes; Motion passed.

Road Commissioner Rodawold presented the Road District bills totaling \$5,307.00. Trustee Donohue made a motion to approve the Road District bills, Trustee Tennant seconded it. Roll call vote was taken, Donohue – yes; Gabriel – yes; Tennant; Motion passed.

Under the Supervisor's report, Supervisor Jay gave his attached report.

There was no Highway Commissioners, Assessor's or Clerk's report.

Under Land Use Report, there was one zoning change before the committee. As there was nothing the Township to do, it was just filed. He also said that John Norton would be working with the Land Use Committee to create an Emergency Plan.

Trustee Tennant made a motion to move the New Business forward on the agenda; Trustee Donohue seconded it. Motion passed by voice vote.

Trustee Gabriel made a motion to approve the Township Budget as presented; Trustee Tennant seconded. Roll call vote was taken, Donohue – yes; Gabriel – yes; Tennant; Motion passed.

Trustee Gabriel made a motion to approve the Assessor's Budget as presented; Trustee Tennant seconded. Roll call vote was taken, Donohue – yes; Gabriel – yes; Tennant; Motion passed.

Trustee Donohue made a motion to accept the Road Commissioner's Budget as presented; Trustee Tennant seconded it. Roll call vote was taken, Donohue – yes; Jay – yes; Tennant; Motion passed.

Under Park Report, Supervisor Jay said that the barbed wire was torn down and a new split rail fence was put up, and 9 new holes added to the Disc Golf Course. He said that signage will now be put up. He reported that he met Joseph Standing Bear, and his group is seriously considering having their POW-WOW at the Park. He is also working on a pro-wrestling event. He said that plans are in the work for a professional fire pit.

There was no Old Business.

Trustee Donohue made a motion to adjourn at 8:31 p.m., Trustee Tennant seconded it. Motion passed by voice vote.
