

Wesley Township Board Minutes

January 12, 2016 – 7 p.m.

The meeting was called to order at 7:04 p.m. by Supervisor Jay. Trustee Tennant led the pledge of allegiance. Roll call was taken by Clerk Vasko. Present were Supervisor Jay, Hwy Commissioner Norton, Assessor Garvey, Clerk Vasko, Trustees Kennedy, Tennant and Smolenski and Spinale.

There was no executive session or public comment.

Motion to approve the December 2015 minutes was made by Trustee Tennant, seconded by Trustee Spinale. Voice vote was taken, motion passed.

The town bills were presented by Clerk Vasko in the amount of \$3,603.73. Motion to approve was made by Trustee Smolenski, seconded by Trustee Tennant. Roll call vote was taken, Trustee Smolenski, yes; Trustee Tennant, yes; Trustee Kennedy yes; Trustee Spinale, yes. Motion passed.

Assessor's bills were presented by Assessor Garvey in the amount of \$1,135.67. Motion to approve was made by Trustee Smolenski, seconded by Trustee Tennant. Roll call vote was taken, Trustee Smolenski, yes; Trustee Tennant, yes; Trustee Kennedy yes; Trustee Spinale, yes. Motion passed.

Road District bills were presented by Clerk Vasko in the amount of \$9,114.69. Supervisor Jay made a motion to approve all but the T. D. Pete's bill for 242.62, seconded by Trustee Spinale. Roll call vote was taken, Trustee Smolenski, yes; Trustee Tennant, yes; Trustee Kennedy yes; Trustee Spinale, yes. Motion passed.

Supervisor Jay reviewed and submitted his report.

Highway Commissioner Norton reported that he had helped the City of Wilmington with road work on Kahler Road and had done some work on Wesley Road but more was to be done.

Assessor Garvey reported that things are going smoothly and in a timely manner.

Under Clerk Report, Clerk Vasko reported that several years of records had been boxed up and put in storage, more was to be done..

There was no Trustee Report.

The Park Report was discussed under New Business.

Under New Business, the transfer of funds in the Road District to pay loans was discussed. The motion to table the discussion until April was made by Trustee Tennant, seconded by Trustee Kennedy. Voice vote was taken, motion was approved.

Under Old Business the discussion about Park fees and regulations was discussed, a motion to table further discussion until the February meeting was made by Trustee Tennant, seconded by Trustee Spinale. Voice vote taken, motion passed.

Motion to adjourn was made at 8:27 p.m. by Trustee Kennedy, seconded by Trustee Smolenski. Voice vote was taken, motion passed.
