

Wesley Township Board Minutes August 13, 2013 – 7:00 p.m.

Supervisor Jay called the meeting to order at 7:01 p.m. Supervisor Jay led the pledge of allegiance. Present were Supervisor Jay, Clerk Gabriel, Road Commissioner Stickel, Trustees Galyon, Jessen, Kennedy and Tennant, absent was Assessor Rodawold

Sandy Vasko reported the land mark nomination is on hold right now, she is still interested just not able to move forward.

Trustee Galyon made a motion to approve the minutes of the July 9, 2013 meeting. Motion seconded by Trustee Kennedy, motion passed by voice vote.

Clerk Gabriel presented the Township bills totaling \$4046.23. Motion made by Trustee Galyon to approve the bills, motion seconded by Trustee Tennant. Roll call vote was taken, Galyon – yes; Jessen-yes; Kennedy– yes; Tennant – yes; Jay - yes. Motion passed.

Clerk Gabriel presented the Assessor's bills from July 2013 totaling \$832.25. Trustee Galyon made a motion to approve the Assessor's bills, Trustee Tennant seconded it. Roll call vote was taken, Galyon – yes; Jessen– yes; Kennedy– yes Tennant – yes; Jay – yes. Motion passed.

Clerk Gabriel presented the Road District's bills totaling \$23,589.94. Trustee Galyon made a motion to approve the Road bills. Trustee Jessen seconded it. Roll call vote was taken, Galyon – yes; Jessen– yes; Kennedy– yes; Tennant – yes; Jay – yes. Motion passed.

Under the Supervisor's report, Supervisor Jay gave his attached report.

Under Highway Commissioner's report, Stickel reported that he has just about all the bills paid up and

Under Park report Supervisor Jay reported that there has been a request for July 2014. The date requested falls during the weekend of catfish days, was wondering if we want to approve that or keep that weekend for the park events that occurred this year. It was unanimous to block that weekend except for park events. Also discussed the need for A frame signs to promote events at the park and the park location in general.

Under Clerk's report, Clerk Gabriel asked that we look into replacing the computer that she uses. It is very hard to type letters and email when the computer can't keep up. She also stated that everyone needs to do their FOI online and turn the certificate in.

There was no Trustee's report

Under New business projects for the park there was a discussion held about getting new gravel for the road down by the river. Want to put in an area to turn around in and a area to park trucks by boat launch. Also want to layout a plan in phases for the park as to want all is wanted for. Trustee Kennedy got estimates for a well for the park they were for about \$6500 or a minimum of 52 feet for a well for a hand pump.

A discussion was held regarding the dam in Wilmington, the need for someone to go to the Chamber of commerce meeting was recommended. Trustee Galyon said he would get more information on this from IDNR and the City of Wilmington.

Motion to adjourn was made by Trustee Galyon at 8:25 p.m. Supervisor Jay seconded. Motion passed by voice vote.
